DESCRIPTION:

Will primarily be responsible to collect and count revenue from slot machine and table games. The employee is occasionally required to stand; walk; and stoop, kneel, bend. The employee must be able to lift and/ or move up to 50 pounds.

RESPONSIBILITIES:

- Provide excellent guest service to guests, internal and external through active guest engagement and positive attitude.
- Responsible to collect and count revenue from slot machine and table games.
- Responsible to reconcile, total, record, and maintain revenue information.
- Must follow all control procedures.
- Must know, understand, and adhere to all policies and procedures of the Casino and Finance Department.
- Will perform all other duties as assigned.
- Reports directly to the Count Team Supervisor.
- Due to the dynamic Casino Environment from time to time, we require employees to be flexible and assume other responsibilities assigned by management.

MINIMUM QUALIFICATIONS:

- High School diploma or GED.
- Must be physically fit to perform job duties including lifting up to 50 pounds and bending.

- Must possess good math skills.
- Must be willing to work weekends, nights, and holidays.
- Must pass background check and other pre-employment screenings.
- Must be able to receive and maintain a Gaming License.

- Previous experience with large sums of money and counting accuracy.
