### **DESCRIPTION:**

Responsible for managing all daily retail operations in the Points Bet Sportsbook in conjunction with property management on staffing, while working directly with Points Bet to manage ongoing business operations. The Senior Sports Betting Concierge will be responsible for achieving business goals and ensure high levels of customer service.

## **RESPONSIBILITIES:**

- Manage the Sportsbook environment including guest experience and lead a small team of Sports Betting Concierges.
- Maintain a clean, safe and fun environment for guests and Sports Betting Concierges.
- Comply with all state and federal regulations as well as organizational policies and procedures.
- Ensure all AML, Title 31 & Suspicious Activity procedures are followed and tracked accurately.

- Verify cash drawers, complete reports, rate customer activity.
- Explain wagering rules including betting lines, odds, and bet types to guests as needed.
- Investigate and resolve any guest complaints or issues that arise.
- Coach, guide and instruct Sports Betting Concierges in the proper performance of duties.
- Ensure compliance with all Minimum Internal Control Standards (MICS) as well as all Tribal Internal Control Standards (TICS)
- Must follow all safety policies and procedures and attend all scheduled safety meetings and training as a condition of employment.
- Perform any other duties that may be assigned from time to time.
- Other duties as assigned to ensure the smooth operations of the Sportsbook.

## MINIMUM QUALIFICATIONS:

- Must have a High School Diploma, or GED
- Must pass background checks and other pre-employment screenings.
- Attention to detail providing superior customer service
- Sports betting and/or sports knowledge
- One to three years prior leadership experience
- Excellent written and verbal communication skills

- Willingness to work a varied and flexible schedule consisting of nights, weekends & holidays
- Superior guest relations, leadership and organizational skills
